Awards:

To be determined by the Membership each year. Currently (25) \$500.00 each.

Applications:

Applications will be available at the Union Hall, 1130 Summit St. Findlay OH

Applications will be a two (2) part application with matching numbers printed on them.

One part of the application will only contain a matching number. This part will be placed in a locked ballot box, at the Union Hall, by an elected official and witnessed by the applicant/applicant's 207L member. The Union may come up with other methods but they must be verified by the applicant/applicant's 207L member.

Eligibility:

Any eligible dependent child, age 25 or younger, (**as defined by the Employee Pension and Insurance Program**) of a member in good standing of USW Local 207 L, enrolled/enrolling in this year as a full time student in an accredited college or university, is eligible for this award.

Anyone receiving full academic/athletic scholarship is not eligible for this award.

Winners of this award cannot re-apply.

This scholarship is not restricted by any sex, race, religion, color, disability, veteran status or natural origin.

Drawing:

Applications will be accepted until April 30th.

The drawing will be held at the Regular May Monthly Business Meeting/Meetings.

A Trustee or a Nonparticipant will draw the winnings ballots from the ballot box during the meeting/meetings.

Disbursements of Funds:

All scholarship money will be sent directly to the college/university that the winners will be attending.

Scholarship money can be used for tuition, room and board or general fees, and may be applied to the students balance before any money from student loans.

Excess funding will be returned to Local 207 1
